Informed Consent, Release, and Waiver: Please read and sign.

By my signature below, I consent to the administration of the vaccine for SARS-CoV-2, the virus that causes the Coronavirus Disease 2019 (Covid-19). I consent to be contacted at the number provided above regarding any required second dose of this vaccine that I may be due to receive. I understand, affirm, and acknowledge that:

- 1) I am of legal age and authorized to execute this consent form.
- 2) **If the vaccine recipient is a minor or an adult that is incapable of giving consent**, I acknowledge by signing below that I am a parent or guardian with legal authority to execute this consent form on behalf of the minor receiving the vaccine and that all responses to the screening questions pertain to the minor on whose behalf I am acting.
- 3) I have the option to accept or refuse the Covid-19 vaccine and I voluntarily consent to receive the vaccine.

- 4) The vaccine I am receiving is subject to Emergency Use Authorization (EUA) by the U.S. Food and Drug Administration (FDA), which permits the vaccine to be administered for emergency use when there are no adequate, approved, and available alternatives.
- 5) I have received, read, or have had read to me, the *EUA Fact Sheet for Recipients and Caregivers* provided for the vaccine to be administered and understand the benefits and risks of the vaccine to the extent such benefits and risks are currently known.
- 6) In addition to my answers to the questions on this form, I will immediately alert the health care provider before receiving the vaccine of any medical conditions which may adversely affect my personal health or the effectiveness of the vaccine.
- 7) I have been counseled about potential side effects after vaccination, when they may occur, and when and where I should seek treatment. I have also been counseled that there may be side effects or risks to the vaccine that are not identified in the *Fact Sheet for Recipients and Caregivers* and therefore cannot be reasonably known to the health care provider. I understand that I am responsible for following up with my primary care provider or other appropriate health care provider of my choice if I experience any side effects.
- 8) I have had the opportunity to ask questions, and all my questions have been answered to my satisfaction.
- 9) I have been advised that I should remain in the area for 15 minutes after the vaccination for observation.
- 10) This vaccination may be subject to reporting to federal and state health oversight agencies and to my primary care provider, if applicable, and I authorize these disclosures.
- 11) **Release and Waiver:** I fully release and discharge the health care provider, its subsidiaries, affiliates, officers, directors, employees, and agents from all liability, including acts of omission or commission, relating to, or arising from, my receipt of the vaccine and I knowingly and voluntarily waive any and all claims or causes of action I may have against them related to, or arising from, my receipt of the vaccine.
